

OUR BELIEFS

STRATEGY

Ashish Foundation works to empower students and families, in the communities where they live and equip individuals, organisations and communities to include persons with autism and developmental disabilities as valued members of the society.

Our Centre strives to facilitate the student to participate in society by assisting them to have independence and to develop valued social roles. From the time the student enters the doors of the Ashish Foundation, we begin exploring their unique gifts and interests. We collaborate with other stakeholders to help the student develop competencies so that these gifts and interests can blossom into roles that are valued in the community.

We have three programmes

Ashish Centre, focuses on comprehensive learning and development of students ranging from 3 to 17 years old. They develop foundational valued roles common to typical children, such as student, household member, citizen, and an aficionado of different hobbies and pastimes.

Ankur, the vocational program tailored for individuals aged 18 and above, enables participants to unlock their potential through practical training in various job skills and personalized support for customized employment. Participants develop valued roles common to adults, such as employee, friend, and member of interest-based groups.

Advay. Advay empowers parents and educators to help the individuals they support to develop valued roles in society. Workshops under Advay provide theoretical and practical training for stakeholders who work directly with children and adults with developmental disabilities. Additionally, Advay conducts programs aimed at raising awareness about disability issues, fostering greater acceptance and support for individuals with disabilities within society at large.

We are empowering other organizations and networks in the disability field to facilitate the development of valued social roles to the people they work with and provide an atmosphere of inclusion within the community.

We had a Collaborative Assessment by a 5 member team from Keystone Institute India which generated recommendations to strengthen the program and safeguard its ongoing development.

Our Finance, Administration and Human Resources roles provide support for our programs to run seamlessly.

We have adhered to all statutory requirements with our annual accounts being audited by an external auditor.

PROGRAMMES

We aspire for our students and individuals with disabilities to experience the positive aspects of life. Unfortunately, when they face neglect, underestimation, or differential treatment, these enriching experiences become elusive. Such discrimination is regrettably common in various settings like schools, workplaces, communities, and society at large. This unfair treatment hinders individuals with disabilities from leading a life of dignity in accordance with their rights.

To provide our students with access to a dignified life, we have structured our programs based on



the principles of Social Role Valorisation (SRV). By adopting the SRV approach, we assist students in cultivating esteemed roles within the community that are common to typical people, such as chefs, gardening enthusiasts, neighbours, household members, artists, and employees. These valued roles not only open up more opportunities and relationships for individuals but also enable others to recognize their contributions as active participants in community life.

Emphasizing valued social roles underscores the commonalities between individuals with and without disabilities. Through these roles, our students not only enjoy the positive aspects of life but have increased opportunities of positive interactions with typical people in their communities. The acquisition of valued social roles involves skill development. Individual Development Plans (IDPs) are tailored to each student, considering their specific learning needs and the roles they are working towards. IDPs also cover topics that are taught to students in mainstream schools, providing our students with a comprehensive exposure to the world and making their school experience more aligned with that of their peers.

We had a Collaborative Assessment of our programmes in November 16-17, 2022 when a five-member team of evaluators from Keystone Institute India visited our centre to learn the quality of our programmes. The report had a very positive outcome based on recommendations we had implemented in the past, as well as helpful suggestions to continue to improve our programmes. The team also visited our former students at their job site to understand how they have developed in their role as employees.

Rohit – the breadwinner of his family!

Rohit is currently in a supervisory job in a highly technical package inventory management position in Ecom Express, an e-commerce logistics company. He now has the role of sole breadwinner for his family!

Rohit was born with severe physical disabilities, highly vulnerable, considered as being "better off dead". He joined Ashish Foundation when he was nine years old. From the beginning he enjoyed his time at our centre and was sincere in his studies, helping the teachers, and eager to learn new skills.

At Ankur, our Vocational program for young adults, he learned vocational skills very eagerly, including MS Office. In 2018 Rohit was selected to receive hands-on job training at Ecom Express for two months. Later he was appointed as Associate-Operations earning Rs.15000/- and made his family proud.

Rohit enjoys dancing and he used performed a solo dance at Ashish Foundation's Annual Day every year before he joined work



ASHISH CENTRE

Teaching serves as a catalyst for students to grow in diverse area, with educators crafting plans tailored to individual interests and real-world roles. Aligned with students' Individual Development Plans, classes cover comprehensive instructional learning. Post-Covid, we urged parents to transition their online learners to in-person classes, resulting in a significant increase in our student strength to 18 by year-end. The teachers planned the class topics in practical and innovative ways so that students are more highly engaged in their learning.

Our curriculum's strength lies in connecting activities

with real-world social roles, preparing students to adeptly navigate various life aspects. Emphasizing functional academic and life skills, learned in a variety of settings, equips students for independence, benefiting them now and in their future careers.

In class, students enjoy diverse activities, academic sessions, cooking classes, and leisure time. Weekly cooking sessions encourage students to prepare and share tasty dishes, fostering camaraderie and developing their roles as hosts and guests. Before summer holidays in May 2022, a week-long camp featured water play, art, dance, music, and cooking, providing a joyous experience.



Celebrations are also opportunities to develop students' roles as citizens and community members. These included Friendship Day, Children's Day, birthdays, and national festivals. Notable partnerships include the 75th Independence Day celebration with the Tourism Department, Government of India, and celebrating Lohri with Credence Digital. Our 15th Annual Day marked a grand celebration postlockdown, featuring student performances in dance, drama, and song.

Visiting places that typical people experience enriches our students' life and opens opportunities to explore interests that could develop into roles. Students visited parks, had a picnic at Sundar Nurseryon Children's Day, visited the Rail Museum and

experienced the attractions at EOD Adventure Park. They were also able to enjoy the attractions of Pratapgarh Farms along with their family members.

Collaborations with Apeejay Institute of Mass Communication showcased student talent at the We-Care festival, including a well-received fashion show

Through the collaboration of Red Moon Bakery, students were able to decorate Christmas cookies. Friends of Ashish also collaborated by hosting students at their farmhouse for fun activities and tree planting.

Strategic alliances with stakeholders also involved parent teacher meetings and special mapping sessions in which students' family members, friends, and teachers collaborated to map out students' life stories and collectively dreamed of future possibilities. These joint endeavours amplify our commitment to providing a holistic and enriching experience for our students.



ANKUR

Ankur interns developed their future roles as employees by participating in a variety of production activities. They actively contributed to the production of spices, engaging in grinding, processing, and packaging for domestic use. Additionally, they showcased their creative skills by producing and packaging melt-and-pour handmade soaps, decorating Diwali diyas through painting and packaging, and crafting paper bags, both as gift bags and brown paper bags. The latter were then sold at the 'Green Kisan Mandi' for the use of their customers.

Other enriching activities related to employment were realworld tasks on our premises, such as photocopying, printing, stamping library books, collating and stapling handouts, and organizing donated linens and clothing.

Person Centered Planning was conducted for five interns in collaboration with their families and other stakeholders. Five interns went through the Mapping process, which explores the interns' interests, experiences and assets that inform future planning. One intern went through the process of Planning Alternative Tomorrows with Hope (PATH), in which the intern and stakeholders collaboratively plan how they will work towards the interns' future dreams and goals,. Family members supporting the interns required three to four visits to participate in the Mapping and PATH exercises.





Collaborative efforts extended to the development of customized supported employment opportunities for two vocational interns and one former intern. Three staff members received specialised training in this process in order to work alongside these individuals as learning partners.

Friendship Day, celebrated on August 5, was marked by visiting a cafeteria with friends, marking a significant and memorable post-lockdown social engagement. Interns actively participated in various celebrations at the centre, including major festivals like Raksha Bandhan, Diwali, Christmas, Lohri, and Holi, as well as Independence Day, Republic Day, and the Annual Day, where they showcased their talents in dance and song performances. Other joyous moments included birthday celebrations and get-togethers. To develop their role as neighbours, vocational interns baked cupcakes and distributed them to nearby community children on Children's Day.

Interns had opportunities to develop their roles as citizens and tourists by visiting historical sites like the Red Fort and traveling by Metro train with typical people.

A landmark event was the interns' inaugural overnight trip to Sattal, Uttarakhand. This offered a unique opportunity to exercise their role as young adults, as friends, and as tourists. It also instilled confidence in parents to see that their sons and daughters were able to participate in this experience independently.

In February 2023, vocational interns attended an event and exhibition organized by the National Trust, further expanding their exposure. These joint efforts emphasize our dedication to delivering a comprehensive and enriching vocational experience for our interns.



ADVAY

The Advay program encompasses parent workshops, training sessions, and activities geared towards raising awareness about disability and assisting stakeholders in helping develop valued roles for the individuals they support. Throughout the year, parent workshops were conducted, focusing on addressing social devaluation and providing support to help their children reach their full potential.

The Direct Support Professionals training from Keystone covered essential topics such as "Disability is Natural," "Myths, Facts, and Models of Disability," and "Person-Centred Planning." The inaugural workshop in a series for primary caregivers centered on 'Disability is Natural,' aiming to instill a positive perspective on disability. Sixteen parents appreciated the workshop, expressing newfound insights that prompted a shift in their thinking and actions towards disability.

In July, a workshop on 'Myths, Facts & Models on Disability' engaged 11 parents and staff. Participants shared experiences, highlighting the need to dispel negative perspectives, replace myths with facts, and focus on their child's strengths and unique capabilities. On October 8th and November 12th, 2023, we conducted mapping sessions facilitated by Ms. Susan Swyulka, a volunteer. Parents actively collaborated with us by sharing their knowledge, insights, and dreams as we went through the process for planning their child's future.

Recognizing that challenges faced by parents and siblings as they support their family member can impact their

mental health, we provided one-to-one sessions to address their concerns and offer support.

Through get-togethers, parents found a space to relax and connect with others facing similar challenges, with the goal of reducing stress as they realise they are not alone. One such event featured fun activities and refreshments, providing an opportunity for parents to interact informally and form new connections.

In August, a Parents Get-Together

welcomed 10 parents and family members. Active involvement in activities and games fostered a positive atmosphere, allowing parents to interact and forge new friendships during the tea and refreshment session. Janki Devi College, Delhi University, invited us to conduct an awareness program on November 2, 2022, for their students. Our team engaged over 90 female students. The program, titled 'I Choose You,' encouraged the college students to develop friendships with persons with disabilities, as friendship is an essential valued social role that can open many opportunities for mutual enrichment. The session, led by Ms. Susie Sywulka and Ms. Preeta Bhasin, aimed to promote inclusivity and understanding among the students.

She loves working with children and also enjoys cooking. She lives with her husband Subhash Chandra and her son Saurabh who wants to become a chef, is pursuing his graduation.



Transformative journey through training

"I participated in the Customised Employment training conducted by Keystone India in collaboration with Marc Gold & Associates. The transformative journey commenced on September 5, 2022, with a four-day intensive program. This training has significantly altered my perspective on disability and has instilled in me a deep commitment to empowering our interns, enabling them to lead fulfilling lives.

As we began the Discovery process, I quickly realized that my understanding was merely scratching the surface, akin to knowing only the "tip of the iceberg." The training encouraged me to delve deeper, unveiling the hidden abilities that each of our interns possesses. Through home visits, I gained insights into the family and friend ties, as well as the relationships our interns have, enriching our understanding of their backgrounds.

The process involved giving our interns exposure at various levels—socially and within the community—allowing us to identify their skills and interests." Says Preeta Bhasin, Customised Employment Specalist.
