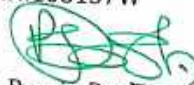
1. The accounts of the trust are maintained regularly in accordance with the provisions of the Act & Rules.

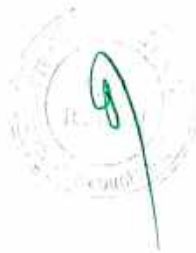

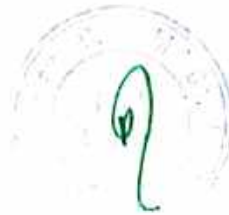
